


Grant Periods

Progress Report 1 due at month 12 of the COST Action, the outcome of which will be taken into account when setting the budget for the following Grant Period;

Progress Report 2 covering the first 24 months of the Action and due at month 25 of the COST Action, the outcome of which will be taken into account when setting the budget for the following Grant Periods

Final Report at the end of the Action – typically month 48. An Action Rapporteur appointed by the COST Association will prepare a Progress Review Report after receipt of Progress Report 2 and of the Action's Final Achievement Report.








COST Members

- Participate in all Actions
- Any researcher and innovator from a COST Member can participate.
- No obligation to nominate a MC member (or Observer, in the case of Partner Member).
- Specific Organisations
 (multinational organisations)
 - European RTDs
 - EU institutions
 - IC





Participation of Individuals

WG member

- Open to any individual affiliated in a legal entity
- Subject to MC approval.
- New eCOST tool to support management of WG members. Information on COST website giving visibility to the concerned individuals.
- Does not entitle individual to be reimbursed for participating in COST Action activities. This remains a decision of the MC under the COST eligibility framework.



Other Participants (ad hoc)







- Number of countries in a COST Action will be:
 - All 40: 38 Full members + 1 Cooperating Member + 1 Partner Member
- WG members will be registered on e- COST and visible on the COST website.

Leadership Positions

Mandatory leadership positions - needed to assure the good implementation of a COST Action.

COST Actions can establish any other leadership positions (according to own needs).

Only Chair, Vice Chair and GH SR need to be MC members.

Grant Awarding Coordinator

- COST Actions will be able to award several types of grants to support the following networking activities:
 - Mobility of researchers and innovators
 - Attendance of conferences organised by 3rd parties
 - Capacity building (limited to young researchers and innovators from ITC or NNC)
 - Dissemination of COST Actions' work and results. (NEW)
- 1 Mandatory position to coordinate the opening of calls, evaluation procedures, etc.
- Can be supported by other leadership positions (or committees) created by the Action.



Main changes



New Leadership Position will need to be elected — **Grant Awarding Coordinator**

No need to be an MC member to take up most of the Leadership positions

Possibility for researchers in the Partner Member, the NNCs and IPCs/third states to take some leadership positions

Action specific leadership positions will be encoded on eCOST and visible on the website.

Dissemination Meeting – is now a Grant

MC Members

up to 2 representatives per COST Full or Cooperating Member

MC Observers

up to 2 representatives per the COST Partner Member

up to 1 representative per specific organisation that is a member of the Action

Substitution of MC Members and Observers

- ✓ Among the WG members affiliated in the same COST Member or Specific Organisation.
- ✓ Indicated by the MC Member and Observer for a specific event or period.







Nomination to the MC


- ✓ At any time, from publication of the MoU until the Action end date.
- ✓ After MC1: tacit approval. 4 weeks to refuse based on a written S&T or Networking justification

For COST Members

CNC nominates an individual and Action receives automatic notification



Action provides justification for rejection?



For Specific Organisations

Similar process than today, simplified and aligned with the nomination from COST Members.

Main changes

No more permanent MC substitutes nor MC Observers from NNC or IPC

Action to approve all MC members within 4 weeks

Reimbursement of individuals

- ✓ MC Meeting:
 - ✓ Open to any relevant participant (even if not MC member) as attendee.
 - ✓ MC can decide to reimburse only 1 MC member per country.
- ✓ Invited Speakers:
 - ✓ No more limit of 4 per event
 - ✓ Concept substituted by ad hoc participant
