Mandate of the Implementation Committee

B. MANDATE

Based on the recommendations of the Organization review committee, and bearing in mind the specific European Landscape of research funding agencies and research performing organizations, the EGO Council mandates the working group for the following tasks.

i) Provide an implementation plan for the recommendations made by the review committee

- Examine the recommendations, prioritize their implementation and setup a timeline for the implementation.
- Identify the bodies who will have to proceed with the implementation (implementation owner), the concerned entities, any foreseeable difficulties and legal aspects.
- Understand concerns of different entities and potential conflicting situations

Mandate of the Implementation Committee

ii) Assiste the execution of the implementation plan

- Prepare or participate in the preparation of the relevant documents necessary for the implementation of a new governance.

- Discuss with all relevant entities concerned with a new governance and elaborate lines of actions with the implementation owners.

- Follow-up with all stakeholders on the progress of the implementation.

The Implementation Committee may consider any other issues that it deems relevant to the Implementation of the aforementioned recommendations.
